National Visa for work or job search in Germany <u>"Opportunity Card"</u>

[Section 20a + 20b Residence Act]

General Information

The Opportunity Card improves your chances of making contact with German employers and finding qualified employment in Germany. Candidates from non-EU countries can enter Germany to look for a suitable job. The Opportunity Card is issued to candidates recognized as skilled workers or those who score at least six points using the points system. Proof of a permanent employment contract is not required. Opportunity Cards are issued for a maximum of one year. The card allows you to look for gainful employment in Germany, i.e., you can seek employment or become self-employed.

While you are looking for gainful employment, you are allowed to have one or more part-time jobs, totaling 20 hours a week. You can also do job trials for a maximum of two weeks per employer as part of your job search. The aim of the job trial must be either to obtain qualified employment, an apprenticeship or a qualification program.



Instructions for using the anabin database


The Central Office for Foreign Education (Zentralstelle für ausländisches Bildungswesen - ZAB) operates the <u>anabin</u> database, which provides information on the evaluation of foreign educational qualifications and universities. The database is currently available in German. This is how the search in anabin works:

<u>1. Search for university (Institutionen)</u>

2. Search for academic degree (Hochschulabschlüsse)

Remark

- It is necessary to carry out both steps, as it is possible that the academic degree is listed without reference to the university.
- The two print-outs of the positive results for the university and the academic degree can then be used together as proof of equivalency when applying for a visa.
- Not all foreign academic degrees or universities are listed in the anabin database. In certain cases, an individual Statement of Comparability is required.
- If the university in anabin is assessed with the status H+/-, the degree must be listed in the detailed display. Otherwise, an individual Statement of Comparability must also be submitted.
